



Kenneth A. Gunn, *Chairperson*

Mr. Gunn currently serves as the Chairperson of the Cook County Commission on Human Rights. He also provides the Commission with a critical line of communication to its sister agency at the City where Mr. Gunn also serves as the First Deputy Commissioner of the City of Chicago's Commission on Human Relations. He has worked in the field of civil rights law for over twenty years with a focus on employment discrimination, housing discrimination, public accommodation discrimination and hate crimes.



Karina Ayala-Bermejo, *Vice-Chairperson*

Ms. Ayala-Bermejo is the Executive Vice President and General Counsel at Metropolitan Family Services and serves as the Executive Director of Metropolitan Family Services' Legal Aid Society. She brings a wide range of experience to the Cook County Commission on Human Rights including legal expertise in the areas of labor and employment law as well as practical human resources experience drawn from service as First Deputy Commissioner for the City of Chicago's Department of Human Resources prior to joining Metropolitan Family Services.



Jack Block

Mr. Block is an Adjunct Professor and Distinguished Practitioner in Residence at Loyola University Law School, where he teaches Mediation Advocacy, Advanced Mediation and a Mediation Practicum Course. Prior to teaching at Loyola, Mr. Block taught at Northwestern University Law School and the National Institute for Trial Advocacy.

As a practitioner, Mr. Block was a partner for many years at Sachnoff & Weaver (now Reed Smith), where in addition to his regular civil commercial practice, Mr. Block engaged in a number of high profile pro bono and public interest cases. For example, he represented Associations of African American, Latino, Asian and Women Contractors who intervened in a lawsuit challenging the City of Chicago's Affirmative Action Construction Program, helped recover more than \$20 million dollars for classes of persons victimized by payday loans, represented victims of brutal, racially motivated hate crimes, and participated in a class action on behalf of women who were illegally stripped searched by the Chicago Police Department. From 2007 to 2012, Mr. Block served as a Deputy Director of the Legal Assistance Foundation (LAF), where he oversaw projects working on a wide range of issues facing those persons living in poverty, including problems related to housing, consumer rights, children and family law, public benefits, employment, veterans and immigration. Together with Ms. Eatherton, Mr. Block led the revitalization of the Cook County Commission on Human Rights mediation program and formed a critical partnership between the Commission and the Center for Conflict Resolution.



Enoch Clarke-Bey

Mr. Clarke-Bey is the former Director of the Taxpayer Information and Customer Affairs Division for the Office of the Illinois Comptroller and a former Administrative Hearing Officer in the Cook County Government Labor Relations Division. He is a certified arbitrator and mediator for the U.S. Department of Justice. Mr. Clarke-Bey, who has a law degree, has demonstrated a lifetime commitment to civil rights issues and has been involved in many significant civil rights causes within Cook County.



Todd Connor

Mr. Connor is the CEO of Flank 5 Academy and CEO and Founder of The Bunker, the nation's first veteran business incubator focused on early-stage growth technology-enabled businesses.

Mr. Connor is a former management consultant, U.S. Navy veteran, and has held many leadership roles in the public and private sector. He is a two time entrepreneur, formerly led the Service Leadership Academies for Chicago Public Schools, and is the author of two books on leadership and personal strategy. Together with Ms. Ratner, Mr. Connor leads the Cook County Commission on Human Rights' educational and outreach efforts.
