

MUNICIPALITY HAS AN OPEN BURNING ORDINANCE	
<p><i>MUNICIPALITY BANS OPEN BURNING OF ALL LANDSCAPE WASTE:</i></p> <p><u>RESULT:</u> Open burning of all landscape waste, including leaves, is not allowed.</p> <p><u>PERMIT:</u> CCDES open burning permit is not required because burning is not allowed.</p>	<p><i>MUNICIPALITY ALLOWS OPEN BURNING OF ALL LANDSCAPE WASTE:</i></p> <p><u>RESULT:</u> Open burning of all landscape waste including leaves is allowed.</p> <p><u>PERMIT:</u> CCDES requires an open burn permit for landscape waste excluding leaves. CCDES does not require a permit for leaf burning.</p>
<p><i>MUNICIPALITY BANS BURNING OF LEAVES ONLY:</i></p> <p><u>RESULT:</u> 1) Open burning of leaves is not allowed. 2) Open burning of all other landscape waste excluding leaves is allowed only under the conditions specified in CCDES ordinance.</p> <p><u>PERMIT:</u> CCDES requires an open burn permit for the burning of landscape waste excluding leaves.</p>	<p><i>MUNICIPALITY ALLOWS OPEN BURNING OF LEAVES ONLY:</i></p> <p><u>RESULT:</u> 1) Open burning of leaves is allowed. 2) Open burning of all other landscape waste excluding leaves is allowed only under conditions specified in the CCDES ordinance.</p> <p><u>PERMIT:</u> CCDES requires an open burn permit for the burning of landscape waste excluding leaves.</p>
<p><i>MUNICIPALITY BANS OPEN BURNING OF LEAVES, BUT ALLOWS OPEN BURNING OF ALL OTHER LANDSCAPE WASTE:</i></p> <p><u>RESULT:</u> 1) Open burning of leaves is not allowed. 2) Open burning of all other landscape waste excluding leaves is allowed.</p> <p><u>PERMIT:</u> CCDES open burning permit is required for the burning of all other landscape waste except leaves.</p>	<p><i>MUNICIPALITY ALLOWS OPEN BURNING OF LEAVES, BUT BANS OPEN BURNING OF ALL OTHER LANDSCAPE WASTE:</i></p> <p><u>RESULT:</u> 1) Open burning of leaves is allowed. 2) Open burning of all other landscape waste excluding leaves is not allowed. <u>PERMIT:</u> CCDES open burn permit is not required.</p>
MUNICIPALITY DOES NOT HAVE AND OPEN BURNING ORDINANCE	

When the municipality does not have an open burning ordinance or is in unincorporated Cook County, the CCDES ordinance, section 30-387-B (3) will be followed:

OPEN BURNING OF LANDSCAPE WASTE, INCLUDING LEAVES, IS ALLOWED ONLY UNDER THE FOLLOWING CONDITIONS:

- 1) the burn is on the premises on which such waste was generated: and
- 2) when atmospheric conditions will readily dissipate contaminants: and
- 3) if such burning does not create a visibility hazard on roadways, railroad tracks, or airfields: and
- 4) open burning **is not allowed** in a municipality that has an ordinance that prohibits it, and **is not allowed** in unincorporated areas within 1,000 feet of a prohibiting municipality.

PERMIT: CCDEC **requires** an open burning permit for the burning of all types of landscape waste except leaves.
