Reconstruction of Lake Cook Road from Raupp Boulevard to Hastings Lane, Buffalo Grove Road from St. Mary's Parkway to Church Road, IL Route 83 from 425 feet south of Lake Cook Road to Buffalo Grove Town Center, and Weiland Road from Buffalo Grove Road to Woodstone Lane. Lake Cook Road existing concrete pavement shall be completely removed and reconstructed with P.C. Concrete Pavement (11) inch along with (12) inch Aggregate Subgrade.
