The following programs, along with online tools such as high usage alerts and email energy use summaries, can allow you to explore steps to reduce your energy consumption, which can reduce your electric bill.

## ComEd Peak Time Savings

Earn a credit on your bill up to **\$60** a summer when you choose to reduce or delay heavy energy usage on certain hottest days during peak times. There is no cost to enroll and no penalty if you don't participate.

## ComEd Hourly Pricing

Electric prices vary hourly, but most people pay a fixed rate. Pay lower rates when demand for energy is low by signing up for this program. On average, you could reduce your electric supply cost by **15%** with hourly pricing compared to what you'd likely pay with ComEd's standard, fixed rates.

## Smart Thermostat Initiative
