Financial Tools and Incentives Subcommittee

Financial Tools and Incentives Subcommittee recommended action regarding.

Sheryl Caldwell presented the details for two tax incentives.

HSG-KRE application for a Class 7b tax incentive. The Property has been largely vacant since K-Mart closed its doors in 2017. HSG intends both to substantially rehabilitate the existing buildings and redevelop the shopping center with new construction. HSG anticipates starting construction in Spring 2019 and would result in approximately 275-310 full time jobs created for the Village of Oak Lawn. The applicant agreed to give the committee an update in 12 months.

• Shree Kaira's application for Class 7c. Shree Kaira plans to construct a two-unit commercial building that will house a Dunkin Donut with drive-thru and a Wing-Stop franchise. The applicant agreed to come back and report to the committee an update on the employment numbers.
