How can I find out the date, time and location of my next court hearing?

The Clerk of Court offers several ways for individuals to learn their next court dates, including by text message, email, and telephone voice message for civil case types and criminal cases; via the free app, Court Clerk Mobile Connect, and by online case search at www.cookcountyclerkofcourt.org for civil case types only, and Illinois licensed attorneys can use the CCC Attorney Portal to search criminal case information. Get a complete listing of text numbers and email addresses for obtaining next court dates at www.cookcountyclerkofcourt.org. See attached flyers for text message information and opting into the Automated Court Reminder System (ACRS) for felony cases only.

What is the best way to contact the Clerk's Office with questions?

Currently, the quickest way to get questions answered by the Clerk's Office is to send an email to the appropriate division, department or district for your case. You may also call the appropriate division, department or district for your case. A complete list of Clerk's Office email addresses and telephone numbers by area is available on the website: www.cookcountyclerkofcourt.org. For general information, call (312) 603-5030.

How can I get copies of my court documents?

To get copies of your court documents, email the specific division, department or district to request document copies by email; or email the specific area to make an appointment to retrieve copies of court documents in-person. Copy fees will apply.

What happens if I miss my court hearing due to COVID-19 issues?

If you or someone in your household has been recently diagnosed with, exposed to or experienced any COVID-19 related symptoms such as fever, chills or loss of appetite, please do not come to court even if you have a scheduled in-person hearing. You should immediately notify your attorney, or the Clerk of the Circuit Court if you are a self-represented litigant, that you are unable to appear. Your attorney may request that your hearing be conducted via videoconferencing or rescheduled. If you come to court while exhibiting symptoms, you will be denied entry if you do not pass the wellness screening.

Frequently Asked Questions

When will the courthouses be open to the public?

Effective July 6, 2020, the circuit court will begin hearing all matters in all Districts and Divisions of the court with the exception of jury trials; while the Circuit Court of Cook County will begin conducting more court proceedings on July 6, most matters will continue to be held remotely via videoconference.

Misdemeanor and felony bail hearings and reviews of bail determinations will continue to be held via videoconference.

In civil cases, matters may proceed except for jury trials. However, matters involving evictions will not be heard through July 31 and until further order. Eviction matters may proceed if there are allegations involving the health and safety of other tenants; an immediate and severe risk to property; or a violation of any applicable building code, health ordinance or similar regulation. In mortgage-foreclosure matters, no final judgments and executions of judgments shall be entered before July 31.

Will I have to report to the courthouse in-person for my upcoming court hearing?

As the Circuit Court of Cook County resumes in-person court operations on July 6, 2020, judges will continue to conduct most cases via videoconference to limit the number of individuals in court facilities during COVID-19. All litigants should consult with their legal counsel or the Clerk of the Circuit Court for information about whether to appear in-person or instructions for participating in virtual court proceedings when approved by the Circuit Court.

In accordance with Illinois Supreme Court Rule 45 (effective May 22, 2020), unless otherwise ordered by the judge presiding for good cause, all attorneys and self-represented litigants shall be permitted to participate by videoconference from a location of their choosing; self-represented litigants in the Sheriff's custody shall be provided access to court proceedings by videoconference or in-person, as ordered by the judge presiding.

Can I pay filing fees or court fines remotely?

Yes, the Clerk's Office accepts payment of fees and fines via pay-by-phone. Instructions on how to pay by phone is available on the Clerk's Office website at www.cookcountyclerkofcourt.org.

Frequently Asked Questions

How can I initiate a civil type court case or file documents in my existing case, remotely?

The Clerk's Office provides Electronic Filing (eFiling) services for initiating a civil case or to file documents on an existing case, remotely. What happens if I miss my court hearing due to COVID-19 issues?

If you or someone in your household has been recently diagnosed with, exposed to or experienced any COVID-19 related symptoms such as fever, chills or loss of appetite, please do not come to court even if you have a scheduled in-person hearing. You should immediately notify your attorney, or the Clerk of the Circuit Court if you are a self-represented litigant, that you are unable to appear. Your attorney may request that your hearing be conducted via videoconferencing or rescheduled. If you come to court while exhibiting symptoms, you will be denied entry if you do not pass the wellness screening.

What type of precautions are being taken to protect people reporting to courthouses?

In courthouses and courtrooms, everybody is required to wear a facial covering and maintain physical distancing. Temperature checks will be conducted, and nobody will be permitted to enter a courthouse with a temperature of 100.4 or higher. People traveling to court should plan on allowing additional time for entry into the building. Courtrooms will be equipped with plexiglass barriers on the bench and decals indicating where individuals should stand and sit. Courthouses will have signs describing and directing physical distancing.

All persons must wear masks or other face coverings in the courthouse including while in the courtrooms. Participants will not be required to wear masks or other face coverings while speaking on the record, and sign language interpreters shall not be required to wear masks while interpreting.

Frequently Asked Questions

What happens if I am stopped from entering a courthouse because I was detected to have symptoms?

The Sheriff's Office will deny entry to anyone who does not pass the wellness screening, wear a face covering or follow the required entry procedures.

All individuals who are denied entry to a court facility will be provided a denial receipt with the facility name, phone numbers to call for further assistance and reason for denial. Anyone who receives a denial receipt should keep it for their records. If a litigant is denied entry to a court facility, the Sheriff's Office will send the litigant's name to the courtroom where they were scheduled to appear, and their presence will be excused. All litigants who are denied entry to a court facility should immediately follow up with their attorney. Self-represented litigants should call the Clerk of the Circuit Court to confirm their next court date. The Clerk of the Circuit Court's Office will also send a postcard to the litigant's address with the rescheduled court date information. Employees who are denied entry should follow up with their work location as soon as possible and submit their denial receipt if requested by their manager or supervisor.


- 1. COUGH? Have you developed a NEW cough recently?

- 4. PAIN? Are you experiencing NEW muscle aches?
- 5. TASTE OR SMELL? Have you noticed a NEW loss of taste or loss of smell recently?
- 6. **SORE THROAT?** Have you recently developed a NEW sore throat?
- 7. TESTED POSITIVE? Have you tested positive for COVID-19 in the last 14 days?
- 8. **CLOSE CONTACT?** To the best of your knowledge, within the last 14 days, have you come into close contact with anyone who has tested positive for COVID-19?




