#### **Cook County's Unsung Heroines**

As an annual event in observance of Women's History Month, the Commission on Women's Issues honors one woman from each of the seventeen County districts, and an eighteenth honoree, selected by the four at-large members of the Cook County Women's Commission. All eighteen women are recognized for their vital contributions to their respective communities. The award places these women's achievements within the larger fabric of history and commemorates the powerful impact women have had on the development of our social, cultural, economic, and political institutions. The County honors these remarkable women as a way to bring their stories to light, to thank them publicly, and to celebrate the tradition of achievement and commitment to the greater good that is embodied by women leaders throughout the history of Cook County. Although their stories do not usually make the news, their contributions are truly newsworthy. These women are being recognized for using their time, talent, spirit, and enthusiasm to enrich and improve the lives of others

#### Peggy A. Montes Unsung Heroine Award

Peggy A. Montes, an educator, fundraiser, leader, and champion of women's issues and rights, was the driving force behind the creation of the very first Unsung Heroine Award for the women of Cook County. As a way to recognize and honor her remarkable achievements, in 2010 the award was renamed the "Peggy A. Montes Unsung Heroine Award." On March 16, 2010, the Cook County Board of Commissioners acknowledged Ms. Montes in a special way by introducing a resolution honoring her as a true heroine and officially renaming the award in her honor.

#### **CRYSTAL E. GARDNER**

Crystal Gardner is a Union Organizer and Community Activist. Crystal stands firmly in her belief that fighting for social justice on the job and within her communities is an assignment from God, and the only way to enhance the quality of life of our most vulnerable sisters and brothers is through progressive organizing and people power.

A proud Westsider, Crystal has made community her professional and personal epicenter. As a Union Organizer for AFSCME Council 31, Crystal has led numerous collective bargaining victories, including organizing the museum workers at the Art Institute of Chicago and UCAN Residential. Spurred on by the unrest post-George Floyd's murder and the pandemic, Crystal created Active Austin!, a thriving Facebook community dedicated to helping her neighbors connect. She also founded a bipartisan "Protest to the Polls" campaign in 2020 focused on creating community change agents through voter education, engagement and the registration of Black and Latin voters on the west and south sides of Chicago. Crystal currently serves on the board of the Austin, faith-based criminal justice reform organization, The Justice Renewal Initiative, and is a lead for the Austin Coming Together Quality of Life Plan. Most importantly, she wants everyone to know that she is only getting started.

#### **ASIAHA BUTLER**

# 2<sup>nd</sup> District Dorian Carter, Cook County Women's Commissioner Dennis Deer, Cook County Commissioner

Longtime Englewood resident, Asiaha Butler is determined to uplift, inspire and change the perception of her neighborhood - often seen as a death trap.

Butler has served on various boards and councils to ensure residents have a voice to address issues that face the community. Through her leadership, she collaborated with educators, concerned citizens, and parents to develop a comprehensive educational plan for community schools and engaged residents in plans grounded in community planning and development.

In November of 2010, she mobilized residents and co-founded Resident Association of Greater Englewood (R.A.G.E) and serves as Executive Director. R.A.G.E. mobilizes people and resources to force a change in the community.

She served as the Action Champion/Chair of the Englewood Quality of Life Housing and Public Spaces Task Force, leads the Buy the Block Home Ownership Campaign and led the Englewood Public Safety Task Force. Butler recently founded her own real estate development company to ensure that housing development in Englewood happens from the bottom up to avoid gentrification or displacement of current residents.

Fire Commissioner Annette Nance-Holt is a 32-year veteran of the Chicago Fire Department (CFD). As the first woman to hold this rank in the history of the CFD, Ms. Nance-Holt has steadily progressed through the ranks of Firefighter, Lieutenant, Training Instructor, Captain, Battalion Chief, Deputy District Chief, 1st Deputy Fire Commissioner to her current position.

A native of Chicago, Ms. Nance-Holt was raised in the Maple Park community on the southside and attended both parochial and public schools. Ms. Nance-Holt's passion has become the passing of commonsense gun legislation. In May of 2007, tragedy hit when her 16-year-old son, Blair Holt, was fatally shot on his way home from school. Since Blair's death, Ms. Nance-Holt has supported parents who have lost a child to gun violence with the creation of the non-profit organization, Purpose Over Pain - an advocacy organization that supports parents who also lost children to gun violence, provides safe and positive outlets for children and youth, and advocates and promotes safer communities in Chicago, Illinois.

Ms. Nance-Holt is a member of St. Sabina Church, Delta Sigma Theta Sorority, Inc., the International Association of Black Professional Firefighters and the African American Firefighters & Paramedics League, where she once served as President and Vice-President.

#### **BELLE K. MCCLANDON**

Belle K. McClandon is a retiree with over 30 years of service as an Administrative Assistant with Cook County Facilities Management Department and over a decade of successful service in materials management. She is a wife of 30 years who has dedicated her life to taking care of others. Her greatest joy in life is spending time with her loving husband Charles, two wonderful sons, and adorable grandson.

Belle demonstrates strong leadership, organizational, team building, and decision-making skills in everything that she does. Her energy, compassion, and creativity—both orally and written—gives her the ability to effectively communicate with the public and her peers in a professional manner. Her personal cancer survivor story has served as a voice of awareness for others.

Belle is one of the amazing community leaders within the 4th District. She developed and organized the first 8700 South Bishop Block Club, where she currently serves as treasurer. Belle is a 26-year member of the Memorial Missionary Baptist Church and currently serves on the missionary, deaconess, pastor support, Sunday school, and bible-study ministries. As a member of the Missionary Ministry, Belle actively works with other members to adopt a homeless shelter throughout the city to provide food and clothing.

Mrs. Jackson also supports indigent families with food gift cards and assists in providing emotional support to these families in their time of need. As a mother of three, she knows the importance of parent engagement and has been an active parent leader that provides mentorship to other new parents. María began as a volunteer at the San Miguel Church, where she taught adults how to read and write in Spanish, as well as teaching English as a second language. Her commitment to her volunteer community work landed her a position as the Family Support Coordinator at the San Miguel School. Maria has championed many initiatives: coordinating food and coat drives, flu and covid vaccines health fairs with healthcare professionals, and connecting her community to mentors, and legal aid Maria coordinates weekly peace circles, to address the rise in violence and gang activity her community faces during the challenges of the 2-year pandemic. Maria is in the initial planning stages of creating a recreational club for seniors with crafts, board games, and dance classes. Her tireless devotion to creating opportunities for obtaining resources, and connecting families to culturally competent services, has changed the lives of many residents of Chicago's southwest side community.

Arielle Strauss, at age 12, started the Good Breakfast Cereal Drive and Milk Fund as her Bat Mitzvah Service Project. The project turned into Arielle's lifelong passion. The project initially started as a monthly cereal and milk drive at River Grove School. Arielle partnered with the school's student council to hold monthly cereal drives. With the assistance of her family to help Arielle transport the cereal to the food pantry, and fund a treat for the class that brought in the most cereal each month the project took off. With Ariella's energy and compassion the food drive project became an annual fundraising campaign to fund the River Grove Food Pantry. In the last 12 years, over 6,800 boxes of cereal have been collected. Now every August the food drive letter campaign generates donations from local businesses, family, and friends which has raised over \$17,000. Arielle, now 24 years old, the catalyst to a decade-long food drive, has witnessed the generosity of her northwest Cook County suburban community. Arielle could never have imagined that the impact of a young girl's Bat Mitzvah project would continue for over a decade. Arielle is humbled and thankful for how giving her community has been to those less fortunate, and for her own family, especially her mother for supporting and encouraging her dream.

Kathy aimed to highlight Patrick's passion for helping others in the Mt. Greenwood community by creating Pat's Pantry. Pat's Pantry operates out of Mt. Greenwood Community Church and provides food assistance to residents in need. The Pantry provides fresh food to make delicious and nutritious meals through partnerships with local businesses and the surrounding community. Kathy's passion for volunteering flourishes through Pat's Pantry and the Pantry has become a wonderful tribute to her son Patrick's memory and his love of the local community.

Michelle Valiukenas is a mother who co-founded The Colette Louise Tisdahl Foundation with her husband. The Foundation is a nonprofit whose mission to improve outcomes of pregnancy and childbirth and support families dealing with the loss of a child. Their flagship program financially assists families coping with high-risk and complicated pregnancies, NICU stays, and loss. To date, the organization has helped over 1,000 families in 42 states and given away almost \$1 million in grants. Michelle co-leads a support group for parents who have lost babies participates in Mom Congress and other programs to advocate for legislative change on maternal and infant health issues. In efforts to build awareness and advocate for change, Michelle actively shares her own story of loss and other families she has supported. She has also served on the Northfield Township's Commission on Human Services. Michelle Valiukenas is the proud mom of three; Sweet Pea, who she lost to miscarriage, her daughter Colette Louise who she lost at nine days old; and her only living child Elliott Miguel, who is 18 months old. Michelle lives in Glenview with her son Elliott, her husband Mark, and dog Nemo.

#### **DOMINICE LAPORTE**

Dominice Laporte has a passion for advocating for mental health – whether as a volunteer, as the Vice President of Human Resources at Northwest Community Healthcare, or as a board member of the Kenneth Young Center (KYC), a not-for-profit that provides mental health services, youth empowerment programs and care for older adults. When Dominice began as KYC board of directors' chair, she was the only female member. By the end of her two-year term as chair, she recruited four women to the board. She mentors young adults, women, minorities, and people with mental illnesses. She also serves on the Roosevelt University Workforce Advisory Board, was elected president of the local PTA, and was a Scout Leader.

During her more than 25 years in Human Resources, she's created a sense of community and belonging, encouraging employees to connect to their purpose and each other. The daughter of a nurse, Dominice's priority today is to support 4000 employees and frontline caregivers through the pandemic with empathy, providing well-being resources to protect their mental health. For Dominice, building a resilient and connected community means speaking up and making a difference for the most vulnerable. Along with her husband Ray and adult children Michael and Elizabeth, she actively works to eradicate mental health stigma and pave the way for lasting change.

#### **JAMIE KUCERA**

Jamie Kucera has been the Executive Director/CEO at the Pav YMCA for the last 10 years but has served the organization and community in the Y movement for over 22 years. Her mission is to provide others the opportunity to build a healthy spirit, mind and body, even though the most challenging times.

Throughout the pandemic The Y has stepped in to provide necessary resources for the community with limited financial means. The organization has partnered with Alivio Medical Center to administer nearly 10,000 COVID-19 vaccines. The YMCA has provided over 15,000 emergency food boxes to seniors to allow them to stay safely in their home and have sustainable food. Led by Jamie, the Y has created a distribution system to provide shelf stable food items and fresh produce twice a month to the community to fight food insecurity among seniors, distributing over 20,0000 bags of food to those in need. The Y also opened their doors to families in need of childcare and remote learning support when schools were forced to close and has been host to over 20 blood drives in the last few years. Jamie has worked tirelessly to secure funding through grants and federal assistance programs to keep people employed and the doors open at the Y.

#### **DONNA ADAM**

Donna Adam is the founder of Clean Up - Give Back, a non-profit that conducts trash cleanup campaigns in the Chicagoland area and operates a national "Flexible Service Program" that allows individuals to earn service hours for work, school or court while beautifying their community. She is a resident of Des Plaines and has a passion for building community while engaging volunteers. Donna was one of 22 recipients of the 2020 Governor's Volunteer Service Award, which is the highest award in the state of Illinois for volunteerism. In 2021, Clean Up - Give Back conducted 82 small and large cleanups, (16 of these in the Cook County Forest Preserve), where 1,379 volunteers were engaged, contributing 9.527 service hours to the community, filling 4,582 trash bags, and removing 41,814 pounds of trash from the environment.

The Purple Ribbon Chef was founded by Carlisa Thomas, a mother, chef, Lupus patient, domestic violence survivor and advocate. After being diagnosed with Lupus in eighth grade, Carlisa became a champion for others who suffered with this illness. She saved money from her summer jobs to run a candy store and used a portion of her earnings to help people with Lupus.

In 2011, Carlisa started her own Lupus organization, Loop-Us. Its mission is to bring this chronic autoimmune disease that heavily affects women many more times than men to the forefront and provide support for women and girls' needs and to stay healthy and mentally positive.

After leaving an abusive marriage, she combined her skills and passion to start her own catering company, Purple Ribbon Chef. A portion of her revenues are donated to charities.

Carlisa believes women can do anything. "From the beginning of time, we have had to carry the world on our shoulders whether it be supporting our husbands and being the backbone of the family, supporting and raising families on our own, and that incredible thing that we call childbirth. We can start and run successful businesses. We can run multimillion-dollar companies, we can preach, we can teach, we can love, we can nurture."

#### **Audra Wilson, Chairperson**

Audra Wilson is President and CEO of the Shriver Center on Poverty Law, an Illinois-based organization that litigates, shapes public policy, trains, and convenes multistate networks of public interest attorneys to make equal justice and economic opportunity a reality. Audra began her legal career as a Welfare Advocacy Staff Attorney with the Shriver Center 20 years earlier, where she focused her work on food security issues and advocacy for low-income working families. Prior to returning to Shriver, Audra was the Executive Director of the League of Women Voters Illinois and served as the Deputy Chief of Staff for United States Congresswoman Robin Kelly in the Second Congressional District of Illinois for five years. She also spent seven years on the faculty at Northwestern University Pritzker School of Law as an Adjunct Professor and Director of Diversity Education and Outreach. In addition to launching several major diversity initiatives, Audra developed and taught a seminar analyzing the history of U.S. welfare programs and impact of social attitudes on contemporary welfare policy. Audra also served as the Deputy Press and Policy Director on Barack Obama's U.S. Senate campaign

#### Dr. Aparna Sen-Yeldandi, Commissioner At-Large

Dr. Aparna Sen-Yeldandi has worked over two decades in public and private sectors in the areas of teaching, information technology, university research and strategic planning. During her tenure in the City of Chicago and Chicago Housing Authority, she has worked with many human services agencies and spearheaded many inter-governmental projects. Commissioner Sen-Yeldandi is the former Executive Director of Apna Ghar (Our Home), a human rights organization working to end gender violence. Commissioner Sen-Yeldandi served as a Co-Chair on the Board of Chicago Metropolitan Battered Women's Network. She also serves on the advisory council of Women's Economic Justice. Commissioner Sen currently works for the State of Illinois in her role of Executive Management.

#### Andrea A. Raila, Commissioner At-Large

Andrea A. Raila is a Senior Analyst at Raila & Associates and mother of three. She has devoted 34 years to educating the public on private and public financial management, built a 20-year partnership with the Federal Reserve Bank and the Community Investment Corporation advocating financial literacy. She founded Andrea A. Raila & Associates, a public policy and tax consulting firm, recipient of the BBB Torch Award for Marketplace Ethics. Her firm merged into the law firm of Raila & Associates owned by her sister Paula Raila, JD. The firm has a robust internship program that mentors CPS and university students. Andrea values public civil service serving as a Cook County Board of Review Tax Deputy and in the Chicago Comptroller Department's first Taxpayer Advocate Office. She was the first woman candidate for Cook County Assessor's Office in 2010 and 2018. Andrea hosts international exchange students, served on the executive board for the Chicago Legal Advocacy for Incarcerated Mothers, playing a pivotal role in their merger into the Cabrini Green Legal Aid. Since 2009 Andrea served on the Cook County Commission on Women's Issues and serves as President to the Mundelein College Alumnae & Gannon Scholar Association Board at Loyola University.

Vera Garner Davis is a retired educator from Chicago Public Schools. Since retirement, she has worked with several organizations that provide needed services to the community.
