- 8 new cases have been filed so far in the third quarter.
- 8 cases closed in June.
- \$8,500 Settlement amounts disclosed to the Commission.
- **Policy:** Department Director and Policy analyst facilitated 5 Paid Leave Town Halls for suburban Park and School Districts. Commission staff would like to continue the discussion on potentially clarifying in the Human Rights Ordinance Procedural rules the circumstances during which a Respondent would not be served when a complaint is dismissed for procedural defects. Plan to provide a redline proposal at the next meeting.
- **Outreach:** Update on events and training attended to continue departmental efforts to spread awareness of Cook County Human Rights and Ethics ordinances and protections. Specifically training on Fair Housing, the Just Housing Amendment, and worker protections. Request

for Human Rights Commissioners to attend outreach events to amplify protections.
