I am pleased to present Cook County's Annual 2020 Sustainability Report, which outlines the County's efforts to support healthy and resilient communities that thrive economically, socially and environmentally.

Equity played a vital role in the County's work in 2020. Our residents who live on the south and west sides do not have the same life expectancy as their neighbors to the north and in the heart of the City. These underserved communities continue to be at the forefront of our work to create a more sustainable and equitable Cook County. A few highlights of this work include:



- Releasing Cook County's Clean Energy Plan that details the path to fight climate change by
  ensuring that County-owned buildings are carbon neutral by 2050 and using 100 percent renewable
  electricity by 2030. Fighting climate change helps under-resourced areas and communities of color
  who are disproportionally at-risk to heat waves, flooding, poor air quality and greater likelihood of
  new diseases due to existing social, economic and health inequities.
- Launching the Fair Transit pilot program, which reduces fares up to 50 percent on the Metra Electric and Rock Island lines and enhances service on Pace's 352 Halsted route. This project will allow residents in south Cook, some of whom now spend half their income on transportation, to save time and money on public transportation while reducing pollution from automobiles.
- Helping fund community bike and pedestrian path improvements, kicking off a Brownfield Revolving Loan Fund Program to help communities clean up polluted land and getting sites back on the tax rolls as well as launching the Cook County Solar Schools Program are additional accomplishments featured in this year's sustainability report.

Fighting climate change and creating a cleaner environment ultimately helps relieve the burdens our underserved communities face. I am grateful for the progress the County has made to create a more sustainable environment for future generations to live long, healthy lives.

# \$8,500,000

Granted 30 municipalities for transportation projects through Invest in Cook. 15 projects are focused on bicycle and pedestrian path improvements. Approximately 70% of Invest in Cook funding is directed towards projects in low and moderate income communities to create equal access to opportunity.

## Brownfield Redevelopment:

The Village of Bellwood received the County's first loan to clean up a contaminated site so it can be put back into productive use while protecting residents' health. This funding allows a former gas station and auto repair site to become new housing that will help keep growing families in the Village.



# Clean Energy Financing

The Bureau of Economic Development is launching a **Commercial Property Assessed Clean Energy (C-PACE)** financing tool to positively impact the bottom line of businesses, create local jobs, preserve building stock and help the environment. Eligible property owners will have access to low-cost, long-term funding for clean energy, energy efficiency and water conservation projects.


# Equity




## Fair Transit South Cook









Reductions were made in overall County GHG emissions, County building emissions, transportation emissions and total water use.
