#### COOK COUNTY DEPARTMENT OF REVENUE TOBACCO TAX ORDINANCE NOTICE OF 2013 TAX RATE AND DEFINITION CHANGES

## FOR YOUR INFORMATION: 2013 TOBACCO ORDINANCE CHANGES – EFFECTIVE JANUARY 1, 2013

### Smokeless and Smoking Tobacco Tax Rate Increase:

Pursuant to Section 74-433 (d) (2) of the Cook County Tobacco Tax Ordinance, as amended on November 15, 2011, the Tobacco Tax on both Smoking Tobacco and Smokeless Tobacco is \$0.60 per ounce (2012 tax rate \$0.30 per ounce)

### Large Cigar Tax Rate Increase:

Pursuant to Section 74-433 (d) (2) of the Cook County Tobacco Tax Ordinance, as amended on November 15, 2011, the Tobacco Tax on Large Cigars is \$0.30 per Cigar (2012 tax rate \$0.25 per Cigar)

• Large Cigar means any roll of tobacco, other than a cigarette, wrapped in leaf tobacco or any substance containing tobacco and weighing more than <u>three</u> pounds per one thousand units.

### **Retailer Smokeless Tobacco; Smoking Tobacco and Large Cigar 2012 Ending Inventory Tax Due:**

Section 74-435 (a) provides that it shall be a violation of this article to engage in the sale, possession or use of any smokeless and smoking Tobacco subject to any tax provided by this article upon which said tax has not been paid. Therefore Retail Tobacco Dealers are required to remit the additional amount of tax due (\$0.30 per ounce) on all Smoking Tobacco, Smokeless Tobacco and \$0.05 on all Large Cigars in their possession or control at 11:59 pm on <u>December 31, 2012</u> to the Cook County Department of Revenue (DOR) on forms prescribed and issued by the Cook County Department of Revenue.

# FOR YOUR INFORMATION: 2013 TOBACCO ORDINANCE CHANGES – EFFECTIVE <u>MARCH 1, 2013</u>

<u>**Cigarette Tax Rate Increase:**</u> Pursuant to Section 74-433 (a) of the Cook County Tobacco Tax Ordinance, as amended on November 2, 2012, effective March 1, 2013 the tax on cigarettes will be \$0.15 per cigarette (2012 tax rate \$0.10 per cigarette). Further information regarding the cigarette tax increase and floor tax will be mailed / communicated prior to March 1, 2013

<u>Wholesaler and Retailer Cigarette 2013 Floor Tax Due:</u> Section 74-435 (a) provides that it shall be a violation of this article to engage in the sale, possession or use of any cigarettes subject to any tax provided by this article upon which said tax has not been paid. Therefore Wholesale Tobacco Dealers and Retail Tobacco Dealers are required to remit the additional amount of tax due (\$0.05 per cigarette / \$1.00 per pack of 20) on all Cigarettes in their possession or control at 11:59 pm on <u>February 28, 2013</u> to the Cook County Department of Revenue on forms prescribed and issued by the Cook County Department of Revenue.

**Little Cigar Definition Change:** Pursuant to Section 74-431 of the Cook County Tobacco Tax Ordinance, amended November 2, 2012. Little Cigar means any roll of tobacco, other than a cigarette, wrapped in leaf tobacco or any substance containing tobacco and not weighing more than <u>four</u> pounds per one thousand units (2012 Little Cigar defined as not weighing more than three pounds per thousand units)

**Large Cigar Definition Change:** Pursuant to Section 74-431 of the Cook County Tobacco Tax Ordinance, amended November 2, 2012. Large Cigar means any roll of tobacco, other than a cigarette, wrapped in leaf tobacco or any substance containing tobacco and weighing more than <u>four</u> pounds per one thousand units (2012 Large Cigar defined as weighing more than three pounds per thousand units).

Pursuant to Section 74-435 (a) of the Cook County Tobacco Tax Ordinance, it shall be a violation of this article to engage in the sale, possession or use of any cigarettes and/or other tobacco products subject to any tax provided by this article upon which said tax has not been paid or the stamps affixed and cancelled.
